# Item 1. RESOLUTION 2020-11: RESOLUTION FOR THE CITY OF MARION, OHIO AUTHORIZING THE DIRECTOR OF PUBLIC SAFETY TO EXECUTE THE APPLICATION FOR THE (COPS) COPS HIRING PROGRAM TO INCREASE STAFFING THROUGH THE STAFFING FOR ADEQUATE POLICE AND EMERGENCY RESPONSE (COPS) GRANT

Mayor Schertzer explained that this grant is due 03/11 and has been written with an emphasis on juvenile crime. Chief Collins went on to say that the last couple of years have shown a rise in juvenile violent crimes. They feel there is a problem with the juvenile justice system not holding kids accountable. They have reduced the number of kids in detention 3-fold. The only ones who go into detention are the F-1, F-2, F-3 offenders. Their hope is that they will hold them. Many times, they are released back into the community by Monday and then immediately re-offending. They are making headway sitting down with juvenile court to talk about the safety of the community. This grant would help hire three officers. That would take them to 58/59 officers. They used to be at a high at 67. When they are able to be proactive, it will allow them to provide a juvenile intervention officer (coordinators and liaison with court, schools, children's services, after school activities). The other two would supplement each shift expressing that community type program on that particular shift. This would also include school resource officers in school.

Chief continued to talk about the MPACT program, a culture they have tried to instill in police department. Sometimes the only contact younger children were having with police was in a negative situation. They have made inroads through the MPACT program – officers stop and play basketball with kids. Officers are much more approachable today. They cannot play defense all of the time. When they have enough officers, they can play offense. They are able to do programs that they had to cut in the past.

Mr. Schaber clarified that these officers would be funded out of the general fund when the grant is done. Mr. Daniels explained that there is the possibility that they fill in positions created by attrition or retirement and may not be a net increase by the end of the grant.

Mayor Schertzer stated that there are specific parameters in the grant. Police officers would have full police duty with an emphasis on juvenile crime. They have to continue positions for one year after grant expires.

Chief clarified that the grant dollar amount over three years is \$375,000 and the local share is \$500,538. It is a step-down grant. Mr. Ratliff asked for clarification about that it would cover, i.e. would it include needed equipment, vehicles, etc. There would not be significant cost for outfitting the officer, per Chief.

Mrs. Dyer (N. Grand Ave.) expressed an interest in looking for grants for activities for kids rather than targeting juvenile crime reduction. James Broughton (407 Latourette Street) stated that he believes that the police department only wants to arrest people. He advocated for a teen dance for kids to go to. Clifford Hall (1418 Wilson Drive), who is associated with a church in the area, stated that teenagers are not coming to church. He said that police officers used to volunteer their time to coach baseball. He said this is a community problem.

Mr. Ratliff reiterated that this is a community problem and not something that can be solved strictly by policing, or even by the government. Many improvements have been made to parks, aquatics center, skateboard park, etc. He is hearing positive and proactive things from the Chief, not just enforcement/arrest.

Mr. Daniels shared that he has seen first-hand that the police department does much more than arrests. They do wellness checks, check ins while on vacation, and many other things that save lives.

it goes to trial. He does not know how much money is at stake, but the MOU lays out percentages, as follows: 55% goes to a foundation (with a statewide board, and then boards in each district throughout the state), 15% to the state of Ohio, and 30% to local political subdivisions. The intention is NOT to limit the political subdivisions and allow them to spend the money where they want. This needs to be passed before 03/06. He is an advocate for investing money in first responders (police/fire), who are the first ones on the scene (other than family members). They do not have a time frame on when the money would be received if there were a settlement. The percent to the city is smaller than that to the county, as determined by their experts. Percentages are set. The total amount is not. If another state sues and settles for more than Ohio, there is a clause that will allow Ohio to get what the other state gets.

**Item 3.** Mr. Ratliff stated that he is getting calls regarding a burned out house at Silver and Oak Streets. Director Caryer explained that the Zoning Inspector is working on it and that they are trying to expedite things.

**Item 4.** Mr. Ratliff asked about the number of (blank) tax forms mailed out this year by the Auditor's Office. Auditor agreed to obtain number and get back with him.

**Item 5.** Mr. Ratliff asked about updating the city income tax form to comply with the current city ordinance that raised the minimum from \$200 to \$500 before penalties/interest/fees. The current Auditor's form still has the \$200 amount. He wants to confirm that staff is aware and that adjustments are being made (with possible refunds). Mr. Ratliff, who prepares taxes, noticed it with this year's form, but had not noticed it in other years. Discussion ensued as to whether it was on previous forms and it was agreed that this should be researched.

Item 6. Tara Dyer (485 N. Grand Avenue) shared an incident that occurred at her home on 02/18/2020. A truck ran into her home and pulled the electrical wires off her house. Police and fire were dispatched. She had concerns about driver, who did not want police to be called. Police report said that he had no proof of insurance and no phone number was provided. Driver was not cited. She said that she does not want him cited, but then stated that she was "violated" and that there were no repercussions to this driver. She stated that there are issues of equity and diversity in town. She questioned whether this driver might have been cited if the same thing had happened to Mrs. Swanger or Mrs. Cunningham's house. She is upset that she was "violated", and nothing was

**WHEREAS**, the Council last modified Marion City Code Chapter 911.42, Section C, Part 4 by actions documented in Ordinance 2000-135, and

WHEREAS, Water Pollution Control staff and the Ohio EPA suggest changing this Ordinance to streamline the process of reevaluating and assigning Local Limits as required in the National Pollutant Discharge Elimination System (NPDES) permit,

**BE IT ORDAINED BY** the Council of the City of Marion, Marion County, Ohio:

Section 1: Marion City Code Chapter 911.42 SUBSTANCES LIMITED section C, part 4, first paragraph now reading in part:

(4) Any waters or wastes containing solids, liquids or gasses in sufficient quantity, either singly or by interaction with other wastes, to injure or interfere with the wastewater treatment process, constitute a hazard to humans or animals, create a public nuisance or create any hazard in the receiving waters of the wastewater treatment plant, including, but not limited to, arsenic, lead, mercury, chromium, copper, zinc, cadmium, nickel, antimony, selenium, molybdenum, and silver in the wastes as discharged into the public sewer. No user shall discharge wastewater containing the following pollutants exceeding the concentrations listed below unless issued a wastewater discharge permit by the superintendent specifically allowing higher concentrations. These higher concentrations will be conditioned with other requirements and shall not interfere with the general intent of 911.42.

(4) Any waters or wastes containing solids, liquids, or gases in sufficient quantity, either singly or by interaction with other wastes, to injure or interfere with the wastewater treatment process, constitute a hazard to humans or animals, create a public nuisance or create any hazard in the receiving waters of the wastewater treatment plant, including, but not limited to, arsenic, lead, mercury, chromium, copper, zinc, cadmium, nickel, antimony, selenium, molybdenum, and silver in the wastes as discharged into the public sewer. No user shall discharge wastewater exceeding the maximum limits outlined in the City of Marion Sewer Use Local Limits for Pollutants of Concern. The Safety Director is authorized and directed to extend an RFP for the demolition of the property known as 205 Silver St., Marion, Ohio given his having declared the premises to be in violation of M.C.C. 1360, this declaration being affirmed by the Council herein. Further, the Council authorizes the Safety Director to enter into contract for the demolition of the property with the successful contractor.

The Council having been informed of the basis in regard to the immediate need to declare an emergency under ORC 735.051. For expressed reasons, not limited to: Failing to do so will result in the continue threat of harm to the community given the Safety Director and the Council have further specifically determined this property is an extreme dangerous nuisance as a significantly fire damaged property, no insurance, no living title holder.
