- Displaying insight necessary to provide security throughout the multiple courtrooms and offices of municipal court

It is hereby the ORDER of this Court that William R. Waterman be compensated for his outstanding work in the municipal court in the amount of Ten Thousand Dollars (\$10,000.00).

It is further ORDERED that this Incentive-Merit Bonus shall be paid from the Court Assistance Fund.


It is further ORDERED that federal, state and local taxes shall be deducted as required by law.


It has come to the attention of this Court that reimbursement is requested for services provided to the Court, and the Court finds said services are necessary and are a direct benefit to the Court.

AMENDED JUDGMENT ENTRY

WHEREAS, the Judge of the Marion Municipal Court has determined that, for the efficient operation of the court, additional funds are necessary to assist in the acquisition and payment for special projects of the court including, but not limited to, the acquisition of additional facilities or the rehabilitation of existing facilities, the acquisition of equipment, including but not limited to technical and computer equipment, the hiring and training of staff, incentive programs, community service programs, victim assistance programs, defendant assistance programs, mediation or dispute resolution services, the employment of magistrates, the training and education of judges, acting judges, and magistrates, and other related services of which said funds are often entirely generated by tax dollars and/or allocated from state grants and therefore payable by the general taxpayers of this jurisdiction, and


WHEREAS, the Judge of the Marion Municipal Court believes that, instead, some of this funding for the needs of the court should come from convicted offenders and individuals utilizing the court who by definition create the abovementioned needs.

THEREFORE, it is hereby ordered that effective September 23, 2008, the Clerk of Marion Municipal Court shall charge a total of Ten Dollars (\$10.00) on civil cases at the time of filing; and Ten Dollars (\$10.00) on moving violations, and Twenty Dollars (\$20.00) on non moving violations as additional court costs at the time of disposition in all traffic and criminal cases.

This cost shall be in addition to any other court cost imposed in civil, criminal and traffic cases.

IT IS FURTHER ORDERED that such monies shall be transmitted each month by the Clerk of Marion Municipal Court to the City Treasurer for deposit and credit to the Marion Municipal Court Assistance Fund established and maintained by the Marion City Treasurer.

IT IS SO ORDERED.
