## Item 1.ORDINANCE TO AMEND ORDINANCE NO. 1969-29 (KNOWN AS THE<br/>YARGER REPORT) AS AMENDED, BY UPDATING THE JOB DESCRIPTION AS TO THE<br/>DIRECTOR OF AVIATION AND DECLARING AN EMERGENCY.

Mr. Huddle explained that the job description discussed in the proposed ordinance was discussed at Airport Commission meeting last week with a couple of minor changes to the job description for Director of Aviation.

Mr. Caryer, Service Director, announced that the current Director of Aviation, Mrs. Audrey Wagner, has announced that she is retiring May 31, 2018. The job description is being updated to reflect current needs and certifications in anticipation of upcoming search for a new director. Emergency language is included so that city can begin advertising for candidates immediately.

Deleted language includes:

- "serve as a special police officer at the airport grounds and buildings" (Marion Municipal Airport does not use special police officers and there is no type of certification)
- "one subordinate supervisor who supervises one"
- "National Weather Observation Certificate within twelve (12) months" (only offered for those with a meteorology degree)
- "Ohio Department of Transportation Airport Manager Certificate within two (2) months of being employed" (there is no such certification)

Added language includes:

- Any combination of education and WORK experience that provides the required knowledge, skill and ability may be considered AS A SUBSTITUTE TO FORMAL EDUCATION
- PROMOTES, MARKETS AND IN ADDITION HELPS PLAN FOR ECONOMIC GROWTH OF THE AIRPORT
- A VALID OHIO DRIVER'S LICENSE
