Chief Collins explained that this is transferring a permit from two names into one name. Police and fire have no concerns with this transfer.

## <u>Item 2. Liquor Permit: North Marion Fuel Inc DBA Marathon (847 N. Main Street)</u> (<u>Discussion only</u>)

This agenda item is just an update on status with no action required. This permit had been denied several years ago. City Law Director Russell explained that it was denied (after process) due to proximity to the aquatics center and public park. There is also a rehabilitation facility at the south property line. This notice is the result of a subsequent appeal hearing and shows that no permit has been issued. This permit has been denied twice.

### Items not on the agenda:

Charles Blevins, 220 Blaine Avenue, expressed concerns about Marathon's ability to conduct a successful business without the ability to get license to sell liquor. It was clarified that no liquor is permitted in the park.

Mayor Schertzer explained that this site has been a filling station for a long time and did not hold a liquor license. The park has not just been developed since Marathon's development. This legislative body asked for a liquor hearing and the state chose to not approve the liquor license. There are other locations for sales that have been in existence for a long time and development has occurred around them. That is not this situation.

Mayor Schertzer further explained that there are specific circumstances where a permit can be issued in an alternative location, like a park. These liquor permits are very controlled, often there are police officers present, and there are time constraints put on event.

Mayor Schertzer urged council and residents to take each situation and consider it individually. It is rare that the city requests a hearing.

### Minutes of Legislation Codes & Regulations Meeting

April 17, 2018

Sulu Kelly, 365 E. Farming Street, suggested that business owners should investigate permitting as part of their planning prior to construction and upgrades.

City Law Director Russell concurred and related that beyond the liquor permit issue, these project owners lacked the proper state permits prior to construction.
