# NOTICE TO LEGISLATIVE AUTHORITIES Objections to Renewal of a Liquor Permit

Dear Clerk of Legislative Authority:

This is notice that all permits to sell alcoholic beverages in your political subdivision will expire on February 1, 2020. In order to maintain permit privileges, every permit holder must file a renewal application.

Ohio Revised Code Section 4303.271(B) provides the legislative authority with the right to object to the renewal of a permit and to request a hearing. The hearing may be held in the county seat of the county in which the permit premises is located if that request is made in writing. This will be your only opportunity to object to the renewal of a liquor permit premises which might be a problem in your community.

In order to register a valid objection with the Division of Liquor Control and request a hearing, the legislative authority must pass a resolution that specifies the problems at the liquor permit premises and the legal grounds for the objection as set forth in Ohio Revised Code Section 4303.292(A). It is suggested that a separate resolution be passed for each permit premises. The Chief Legal Officer of your political subdivision must also submit a statement with the resolution that, in the Chief Legal Officer's opinion, the objection is based upon substantial legal grounds within the meaning and intent of Ohio Revised Code Section 4303.292(A). The resolution and Chief Legal Officer's statement must be addressed to the Division of Liquor Control, Attn: Legal Section, 6606 Tussing Road, P.O. Box 4005, Reynoldsburg, Ohio 43068–9005 and postmarked no later than January 2, 2020.

For your convenience, you may access our brochure entitled "How to Object to the Issuance or Renewal of a Liquor Permit" from our website at <a href="https://www.com.ohio.gov/liqr">www.com.ohio.gov/liqr</a> Under "Licensing" click on "Renewals" and under that mega menu please select the link "Object to the Issuance or Renewal of a Liquor Permit".

You may wish to contact the law enforcement agency for your jurisdiction to determine if it has any information which will aid in your decision whether or not to object and request a hearing. For your convenience you may obtain a list of issued permit holders in your jurisdiction from our website at the above link. Under "Liquor Control" click on "Look it up" and under that mega menu please select "Search Permit Holders" "Permit Applicant / Holder Information (types and status)". You will then enter the search criteria for your county / city / township to bring up the issued permits in your jurisdiction. If you do not have access to the internet, you may request a list from us by writing the Division at the below address.

If you determine that there are no permit premises within your jurisdiction that you wish to object to, you do not need to take any action. The renewal applications for those premises will be submitted by the permit holders and will be processed by the Division and issued as appropriate.

# **Permit Objection Process**

# Objections to a new permit, or transfer of ownership and/or location of an existing permit: Who may file an objection?

- Local legislative authority (city council if within a municipal corporation, township trustees or county commissioners)
- Public institutions (schools, churches, libraries, public playgrounds, and township parks) within a 500-foot radius of the proposed permit premises

Once notified by the Division of Liquor Control, the local legislative authority and/or public institutions have 30 days to submit their objection and request a hearing. Only the local legislative authority may request an extension beyond 30 days.

### Objections to a permit renewal:

### Who may file an objection?

Only the local legislative authority can object to annual permit renewals by taking the following actions:

- Adopt a resolution stating the reason for the objection and forward a copy to the division no later than 30 days before the expiration date of the permit.
- Provide a statement to accompany the resolution from the chief legal officer stating it has reviewed the resolution, and, in its opinion, it is based on substantial legal grounds.

## **Hearing Procedure:**

Hearings take place at the division's Reynoldsburg offices, the county seat of the permit holder/applicant, or via video conference where available. The objector must appear for the objection to be considered. The hearing is open to the public, but citizens cannot present evidence or provide testimony unless designated by the objector or permit holder/applicant.

An attorney from the division conducts the hearing, but does not make a decision. A report is submitted to the division's superintendent, who decides whether to overrule or sustain the objection.

The permit holder/applicant or legislative authority may appeal the decision to the Ohio Liquor Control Commission. Public institutions have no legal right to appeal the division's decisions.

### **Evidence:**

The division's decision is guided by statutes, rules and legal cases. Evidence must be pertinent to the advisability of granting or renewing the permit. Speculative testimony not supported by sufficient evidence has been ruled by Ohio courts to be insufficient reason not to allow a business to operate. The burden of proof is on the objecting party, and the evidence presented must be:

- Reliable Dependable evidence which can be confidently trusted.
- Probative Relevant evidence which tends to prove the issue in question.
- Substantial Evidence with some weight, importance and value.

### **Statutory Basis to Sustain Objection:**

The grounds for which the division can deny a permit or reject a permit renewal are provided in Ohio Revised Code Section 4303.292.

#### Examples include:

- Conviction for a crime relating to the ability to operate a liquor establishment by the applicant, any partner, member, officer, director, manager or shareholder owning five percent or more of the capital stock.
- An applicant's unfavorable enforcement record and/or operation in disregard of laws, regulations or local ordinances.
- The location of the establishment substantially and adversely interfering with public decency, sobriety, peace, or good order of the neighborhood, or the normal, orderly conduct of a public institution.
- Saturation in the neighborhood such that the permit applied for would be detrimental to and substantially interfere with the morals, safety or welfare of the public.

# Community Options for Dealing with Problem Liquor Permit Premises

There are three ways a community may stop liquor permit privileges at a problem premises:

- · Local option election;
- Padlock procedures to close a nuisance permit premises;
- Local legislative authority objections to the annual renewal of a liquor permit.

### **Local Option Election**

A local option election involves ceasing alcoholic beverage sales of all liquor permit businesses in the precinct. Ohio Revised Code sections 4301.32, through 4305.14 are the applicable laws dealing with local option elections affecting an entire voting district.

A local option election allows the voters of a particular precinct to decide if the sale of beer, wine, or spirituous liquor shall be permitted within the precinct.

More information regarding local option elections may be obtained from local boards of elections. Instructions for local option petitioners are available by calling the Secretary of State's Office at 614-466-2585.

## **Padlock Procedures to Close a Nuisance Permit Premises**

Another option local officials and residents may use is the padlock procedure. By establishing a permit premises is a nuisance, a court may order it closed for one year.

Ohio Revised Code sections 3767.01, 3767.03 and 3767.05 define what constitutes a nuisance, and set the procedures used when seeking to padlock such a location. This type of action is heard in the local court system and may be instituted by any of the following:

- The Ohio Attorney General;
- The law director of any municipal corporation or township;
- The solicitor of any village;
- The county prosecuting attorney;
- Any person who is a citizen of the county in which the nuisance exists.

A padlock action may be brought against any building, room, etc., where alcoholic beverages are manufactured, sold or possessed "in violation of law" and against all property kept and used maintaining it. "Violation of law" includes sales to an underage person, and any food stamp or drug violation. After such an action is filed, if it appears to the satisfaction of the court that such a nuisance does exist, a temporary injunction may be issued restraining the defendant from conducting a nuisance or permitting its continuance until the conclusion of the trial. The court may also preliminarily restrain the defendant from removing or interfering with any of the property that is the subject of the action.

If, at the trial's conclusion, the court finds the material allegations of illegality are proven, the one-year padlocking of the property may be ordered.

Further, the Division of Liquor Control is required to deny the issuance, renewal or transfer of any retail liquor permit if the applicant has been found to be maintaining a nuisance at the premises where the permit is

# Before undertaking a padlock proceeding, the following points should be considered:

- 1. All nuisance actions must be brought in the common pleas court of the county where the nuisance is located.
- 2. Local law officials or prosecuting attorneys are usually in a better position to initiate this type of action, due to two factors:
  - The action must be brought in the local court system.
  - The witnesses are most likely to be local residents or local law enforcement officials. Such familiarity makes case preparation much more convenient and thorough.
- 3. Finally, these types of cases often take a great deal of time. The burden of proof in verifying the existence of a nuisance is higher than the normal administrative burden before the Liquor Control Commission.

# Local Legislative Authority Objections to the Annual Liquor Permit Renewal

Although not required by law, the division informs legislative authorities they may object to annual permit renewals. They must adopt a resolution stating the reason for objecting and forward a copy to the division no later than 30 days before the expiration date of the permit. It must be accompanied by a statement from the chief legal officer that they reviewed the resolution, and in their opinion, it is based on substantial legal grounds.

A hearing is then hosted at the division's offices in Reynoldsburg, the county seat of the permit holder/applicant, or via video conference where available. The objector must appear for the objection to be considered. The hearing is open to the public, but citizens cannot present evidence or provide testimony unless designated by the objector or permit holder/applicant.

An attorney from the division conducts the hearing, but does not make a decision. A report is submitted to the division's superintendent, who decides whether to overrule or sustain the objection

# ORDINANCE AMENDING CERTAIN PORTIONS OF ORDINANCE 2008-125 AND DECLARING AN EMERGENCY

WHEREAS, the City Council for the City of Marion finds it necessary to amend certain portions of Ordinance 2008-125 and such other previously adopted Ordinances in order to carry out the desired end, that being, enabling even greater efficiencies within the Office of the Law Director, and

WHEREAS, the Council finds the modifications, adjustments and amendments contained herein are necessary,

BE IT ORDAINED, by the Council of the City of Marion, Marion County, Ohio:

<u>SECTION 1</u>. The Council finds it necessary to make the following amendments to previously adopted Ordinances referenced below, all previous terms not amended herein shall remain in full force as if fully rewritten herein:

<u>SECTION 2</u>. Section 1 of Ordinance 2008-125 now reading in relevant part as:

Section 1. Beginning on the first day of January 2009, the ... First Assistant Law Director from time to time also referred to as Chief Prosecutor.... The base salary for said position shall be \$ 72,000.00 with all the benefits previously provided the former position.

Shall be amended to:

Section 1. Beginning on the first day of January 2020, the ... First Assistant Law Director from time to time also referred to as Chief Prosecutor.... The base salary for said position shall be \$75,000.00 with all the benefits previously provided the former position.

SECTION 3 Ordinance 2008-125 now reading, in relevant part, as:

Commencing on the first day of 2009 the duties of the Assistant Law Director for Prosecution in the Marion Municipal Court (3rd Assistant) shall be consolidated and combined with those duties assigned to the Second Assistant Law Director. The base salary for the holder of the Office of the newly reformatted Second Assistant Law Director shall be \$40,000 per year, payable semi-monthly.

Shall be amended to:

Commencing on the first day of 2009 the duties of the Assistant Law Director for Prosecution in the Marion Municipal Court ( $3^{rd}$  Assistant) shall be consolidated and combined with those duties assigned to the Second Assistant Law Director. The base salary for the holder of the Office of the newly reformatted Second Assistant Law Director shall be \$42,000 per year, payable semi-monthly.

<u>SECTION 4</u>. All provisions contained in previously adopted Ordinances not modified by the above shall remain in effect as if fully restated herein.

SECTION 5 . That this Ordinance is hereby declared to be an emergency measure necessary for the welfare of the City of Marion and its' inhabitants thereof: given the need to take the opportunity to increase efficiencies; and as such shall take effect and be in force immediately upon its' passage and approval by the Mayor, provided it receives the affirmative vote of two-thirds of all members elected to Council, otherwise it shall become effective from and after the earliest period allowed by law.
