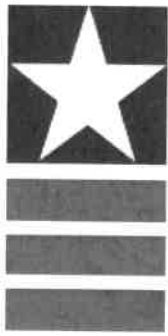

OLD BUSINESS:

Item 1. ORD 2019-49: ORDINANCE AMENDING EXISTING MARION CITY CODE SECTION 660.03 IN ORDER TO ADDRESS EXISTING NUISANCES WITHIN THE CITY OF MARION, OHIO (Legislation and Codes, 2-0, Mr. Landon) (3rd Reading)

Mr. Ratliff requested that the changes be done in two different steps, first add the term tires (change the rule) and then, if problems continue, stiffen the penalty later.

Mr. Daniels stated that 5,500 tires have been removed from the City of Marion and have accumulated over a long period of time. He advocated to keep it as written with both provisions in force. Compliance is the goal of the nuisance officer.

Mr. Landon asked about delaying implementation. There is already a 30-day period until it will be enforced (no emergency clause). Mayor Schertzer encouraged Council to not include anything over a 2-month delay in implementation. This change was requested by the code enforcement officer based on his experience in the field.

It was explained that there are multiple locations available in Marion to dispose of tires for a small fee (per DKMM publication).

Mr. Huddle explained this is for people who volunteer for the city through CPAAA and their service directly reduces the amount of overtime from the police department. This ordinance will supplement some of their costs.

The Police Chief will be responsible to develop additional rules for use with CPAAA. Each year, an amount will be budgeted as part of the annual budget process that is approved by Council.

Item 1. PUBLIC HEARING REGARDING DOWNTOWN REVITALIZATION FUNDS/GRANTS (Regional Planning)

Public hearing opened at 8:12 PM.

Mrs. Warr-Cummings explained that a public hearing is required to discuss the planned budget and purpose when applying for this grant. This is competitive and is for 1-3 buildings at a time. They can have multiple applications going at the same time. This grant is also open cycle. There are two potential applicants: Main Street Reimagined (1 building) and Center Street Grocery Store (3 buildings, but grant would be applied to one building). The grant can be used for roofs, facades, and code compliance with a maximum of \$250,000 per project. They are requesting the maximum and that includes administrative costs. For the Main Street Reimagined project, they will hire Poggemeyer Design to administer. Regional Planning will manage the Center Street Grocery Store project. There is no match on this grant, however both properties will be matching (and more) because of the the size of these projects. This is part of the reason that this makes for a strong application, because it is so costly. Both properties have proceeded with their own funds. If the grants are received, this will just lighten the load for them on this project and allow them to use it in other areas.

ORDINANCE AUTHORIZING THE SERVICE DIRECTOR TO ENTER INTO A CONTRACT FOR THE LEASE OF CERTAIN FARM LANDS ADJACENT TO THE MARION MUNICIPAL AIRPORT AND DECLARING AN EMERGENCY

WHEREAS, the Marion Airport has approximately 577 tillable acres of farm land available for lease.

WHEREAS, the current lease of the farmland expired September 30, 2019.

WHEREAS, the City advertised for and received 3 bids on November 1, 2019.

WHEREAS, the Marion Airport Commission has reviewed the submitted bids and recommended the following as the best bid.

BE IT ORDAINED by the Council of the City of Marion, Marion County, Ohio:

Section 1. That the Service Director is hereby authorized to enter into a lease for a period of three (3) crop years ending September 30, 2022, with Todd Etgen of 1673 County Road 159 Ashley, Ohio 43003, for the above described farm land consisting of approximately 577 acres at a bid price of \$267.00 per acre or \$154,059.00 per year.

Section 2. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council, and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

Section 3. That this ordinance shall take effect and be in force from and after the earliest period allowed by law.

Section 4. That this ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, welfare and safety of the City of Marion and the inhabitants thereof and as such, shall take effect and be in force immediately upon its passage and approval by the Mayor, provided it receives the affirmative vote of two-thirds of all members elected to Council; otherwise it shall become effective from and after the earliest period allowed by law.

RESOLUTION AUTHORIZING AND DIRECTING THE MAYOR OF THE CITY OF MARION, OHIO TO PREPARE AND SUBMIT AN APPLICATION TO PARTICIPATE IN THE OHIO PUBLIC WORKS COMMISSION STATE CAPITAL IMPROVEMENT PROGRAM AND TO EXECUTE CONTRACTS AS REQUIRED, AND DECLARING AN EMERGENCY

WHEREAS, the State Capital Improvement Program provides financial assistance to political subdivisions for capital improvements to public infrastructure, and

WHEREAS, the City of Marion, Ohio is planning to make capital improvements for the Short Street Sewer Improvements (Project 20-1S), S. Grand Avenue Sewer Improvements (Project 20-2S), and Colonial Acres Sewer Improvements (Project 20-3S)

WHEREAS, the infrastructure improvements herein above described are considered to be a priority need for the community and are qualified projects under the OPWC programs,

NOW THEREFORE, BE IT RESOLVED by the Council of the City of Marion, Marion County, Ohio:

Section 1: The Mayor is hereby authorized to apply to the OPWC for funds as described above.

Section 2: The Mayor is further authorized to enter into any agreements as may be necessary and appropriate for obtaining this financial assistance.

Section 3: That this resolution is hereby declared an emergency measure necessary for the immediate preservation of the public health, welfare and safety of the City of Marion and the inhabitants thereof and for the further reason that it is necessary to meet the State Issue 1 deadline; and as such, shall take effect and be in force immediately upon its passage and approval by the mayor, provided that it receives the affirmative vote of two-thirds of all members elected to Council: otherwise it shall become effective from and after the earliest period allowed by law.

ORDINANCE REESTABLISHING THE SALARY AND BENEFITS FOR STATUTORY OFFICE HOLDERS WITHIN THE CITY, OTHER THAN CITY COUNCIL, TO BE EFFECTIVE THE FIRST DAY OF EACH RESPECTIVE OFFICE'S NEXT TERM, AMENDING THOSE RELEVANT SECTIONS OF EACH APPLICABLE PREVIOUS ORDINANCE, AND DECLARING AN EMERGENCY

WHEREAS, the City Council for the City of Marion, being prohibited by State law from granting in-term pay increases to its statutory office holders and therefore has historically reviewed the compensation and benefits provided said office holders prior to the beginning of each respective office's next term, and

WHEREAS, the Council has thoroughly reviewed each statutory office, specifically the Council positions, and finds a real and present need, in order to provide fair and just compensation and in order to continue to attract competent and proficient persons to serve in the aforementioned offices, and

WHEREAS, the Council has approved annual pay adjustments for the City's respective bargaining units and by previous Ordinance has provided for annual pay adjustments for the City's non-bargaining positions, and

WHEREAS, the Council finds the following adjustments to be equitable and at an annual average rate less than that granted bargaining or non-bargaining employees during the previous four years,

BE IT ORDAINED, by the Council of the City of Marion, Marion County, Ohio:

SECTION 1. The Council herein provides for the following salary and benefits adjustments for statutory office holders within the City, each change to be effective the first day of each respective office's next term and amending the applicable sections of existing Ordinances as follows:

Section 1 of Ordinance 2015-91 now reading as:

Section 1. That commencing on the first day of January 2016 the annual salary for the holder of the office of City Auditor shall be \$64,900.00.

Shall be amended to read:

Section 1. That commencing on the first day of January 2020 the annual salary for the holder of the office of City Auditor shall be \$66,500.

Section 2. All provisions contained in previously adopted Ordinances not modified by the above shall remain in effect as if fully restated herein.

Section 3. That this Ordinance is hereby declared to be an emergency measure necessary for the welfare of the City of Marion and its inhabitants thereof: given the prohibition against in-term pay increases contained in Ohio law and that the present time is the historic review period for adjustment and the need to conclude the review prior to the beginning of the next term; and as such shall take effect and be in force immediately upon its passage and approval by the Mayor, provided it receives the affirmative vote of two-thirds of all members elected to Council, otherwise it shall become effective from and after the earliest period allowed by law.

WHEREAS, the City Council for the City of Marion, being prohibited by State law from granting in-term pay increases to its statutory office holders and therefore has historically reviewed the compensation and benefits provided said office holders prior to the beginning of each respective office's next term, and

WHEREAS, the Council has thoroughly reviewed each statutory office, specifically the Council positions, and finds a real and present need, in order to provide fair and just compensation and in order to continue to attract competent and proficient persons to serve in the aforementioned offices, and

WHEREAS, the Council has approved annual pay adjustments for the City's respective bargaining units and by previous Ordinance has provided for annual pay adjustments for the City's non-bargaining positions, and

WHEREAS, councils position is unique in that health care benefits are not offered nor is council eligible to have a city funded health savings account.
