Adjustments include: income tax credit card fees, street improvement grant, law enforcement trust (over appropriated), police (overtime, purchase of new vehicles), and storm water credit card fees.

She clarified that the city pays \$3 fee on credit card transactions regardless of amount of transaction.

Item 6. REQUEST FOR TRANSFER OF FUNDS WITHIN THE SAFETY/GENERAL FUND (Tom Robbins)

Service Director Caryer explained that request is to cover fuels and other items for weed and grass program.

Mr. Daniels asked about future plans for weed and grass program. Mayor Schertzer explained that Safety Director Robbins is administering the program. They have hired a PT seasonal person, and the parks department has hired additional PT seasonal for moving. They were overwhelmed in the early part of the season with what is a new program to the city. We hope to get better at doing this as years go by. There has been a learning curve. Some areas are better, some are not. Some homes have been problems for 10 years.

Mr. Daniels stated that we have 2 people mowing. In talking with them and the coordinator, he got the impression that we may need to take on additional individuals to get this done. Is that true.
